

Foreigner who is a spouse or a registered partner or a minor child (adopted child), including the minor children of the spouse or the registered partner, of a citizen of Australia, Belarus, Japan, United Kingdom of Great Britain and Northern Ireland, the United States of America, Canada, New Zealand, South Korea, who is a holder of a national visa or a temporary residence permit
(Article 70.20 of the Visa Procedure)

The foreigner must pay a fee – 120 Eur.

In cases where under existing provisions of law a foreigner is exempt from paying the state fee or consular fee, he or she must submit documents confirming the following circumstances:_____

Biometric data is collected from an applicant – ten fingerprints and a photo (1 color photo (35 x 45 mm)).

Documents submitted by foreigner for multiple-entry national visa:

<input type="checkbox"/>	an application form for the issue of a national visa, completed using the electronic form for filling in the application (the application must be completed in Latin characters and printed with the documents accompanying the visa). The application for a national visa can be completed on the website https://visa.vrm.lt/epm/ ;
<input type="checkbox"/>	valid travel document (issued in the last ten years with a validity of at least 3 months longer than the period of validity of the visa applied for);
<input type="checkbox"/>	a document confirming family ties with a citizen of Australia, Belarus, Japan, the United Kingdom of Great Britain and Northern Ireland, the United States of America, Canada, New Zealand, South Korea who has a national visa or a temporary residence permit ;
<input type="checkbox"/>	<input type="checkbox"/> a document confirming that they have sufficient funds (e.g., bank account statement) and (or) receive regular income (e.g., employment contract) to subsist in the Republic of Lithuania for no less than 3 months (the sufficient subsistence amount is equal to 1 minimum monthly salary per month); or <input type="checkbox"/> a commitment by a legal entity to ensure monetary income;
<input type="checkbox"/>	a health insurance document: <input type="checkbox"/> health insurance must guarantee the <u>reimbursement of the necessary medical expenses</u> , as defined in the Republic of Lithuania Law on Health, and <u>expenses that may arise due to the return of foreigner to a foreigner state for health reasons</u> (transportation, including escort of a personal health care specialist (specialists)); <input type="checkbox"/> the sum insured must be at least EUR 30,000; <input type="checkbox"/> must be valid during the entire stay in Lithuania and in all the Schengen countries.

NOTES:

Application for the issue of a national visa and accompanying documents shall be submitted to the Lithuanian visa authority in a foreign country or through an external service provider. If the state, where the applicant is legally resident, there is no Lithuanian visa service or external service provider, the application and documents may be submitted to any Lithuanian visa authority abroad or through any external service provider application center. If foreigner is not a national of the State in which documents are submitted for the purpose of obtaining a national visa, he must produce the documents, his legal position in that country. Applicants for a national visa examination reveal that foreigner in the State where the request is illegal, the examination is terminated.

An application for the issue of a national visa and the accompanying documents may be submitted to the visa authority in Lithuania if the foreigner is legally in the territory of the Republic of Lithuania.

If the fingerprints of a foreign national applying for a national visa were taken less than 59 months before the date of submission of the new national visa application, they are copied to a subsequent request. In this case, documents may be submitted by an authorized person on behalf of foreigner for the purpose of obtaining a national visa. They must submit a power of attorney approved by a notary or equivalent, or a power of attorney approved by a legal person. An authorized person on behalf of foreigner serving documents to a visa office in Lithuania must be legally resident in the territory of the Republic of Lithuania. If there is a suspicion of foreigner's destination, the authenticity of the documents submitted, the visa official may, in order to ascertain the credibility of foreigner, require foreigner to present the documents personally and, in the event of reasonable doubt as to the identity of foreigner, to take fingerprints without the specified period.

The application and examination of a national visa application accompanied by the attached documents shall be governed *mutatis mutandis* by the provisions of Article 6 of the Visa Code (Regulation (EC) No 810/2009 of the European Parliament and of the Council 2009-07-13) as well as Chapters II and III. If the application for a national visa is submitted in a manner other than that provided for in the Visa Code, the request shall not be considered and the applicant shall be informed thereof.

In the case when only the copies of documents are submitted to the visa service – their validity must be certified by a person or institution that has the right to certify the validity of copies.

Documents, that are issued not in Lithuanian, are submitted to the visa service in Lithuania with a translation into Lithuanian that is certified by a translator's signature.

A document confirming that the foreigner has sufficient funds (bank account statement) and (or) receives regular income to subsist in the Republic of Lithuania can be submitted originally issued in English or an English translation of a document originally issued in another language can be submitted (the validity of the copies of the original documents has to be certified by a person or institution that has the right to certify the validity of document copies). If requested by the visa service in Lithuania, the foreigner has to submit a translation of this document into Lithuanian that is certified by a translator's signature.

Visa service civil servant, in justified cases (for example, in order to clarify the circumstances of foreigner's entry into the Schengen area; in case of reasonable doubt as to the authenticity of the submitted documents or their content; in order to determine whether there are grounds for refusal of a national visa referred to in Article 19 of foreigners Law) may invite an applicant for a national visa for an interview and / or request additional documents confirming the data contained in the national visa application and the accompanying documents.

The decision to issue a national visa is made within 15 calendar days from the date of the request. This period may be extended by up to 45 calendar days.

A foreigner holding a multiple-entry national visa issued on this basis, for the issuance of another multiple-entry national visa on all bases for the issuance of a multiple-entry national visa will be able to apply to the Vilnius, Kaunas or Klaipeda divisions of the Migration Department if they are legally in Lithuania

For citizens of Belarus this simplified procedure will apply until the 21st of March, 2021.
