

**A foreigner who enters the Republic of Lithuania in accordance with the provisions of international or other treaties**

(Article 70.17 of the Visa Procedure)

**The foreigner must pay a fee – 120 Eur.**

In cases where under existing provisions of law a foreigner is exempt from paying the state fee or consular fee, he or she must submit documents confirming the following circumstances: \_\_\_\_\_

**Documents, to be submitted by foreigners for a multi-entry national visa:**

<input type="checkbox"/>	<p><b>an application form</b> for the issue of a national visa, completed using the electronic form for filling in the application (the application must be completed in Latin characters and printed with the documents accompanying the visa). The application for a national visa can be completed on the website <a href="https://visa.vrm.lt/epm/">https://visa.vrm.lt/epm/</a>;</p>
<input type="checkbox"/>	<p><b>valid travel document</b> (issued in the last ten years with a validity of at least 3 months longer than the period of validity of the visa applied for);</p>
<input type="checkbox"/>	<p><b>documents specified</b> in the international treaty, or, if not specified, documents confirming the purpose and conditions of entry specified in the international agreement.</p> <p>The Government of the Republic of Lithuania and the Government of Canada have signed an agreement on youth exchanges with the Government of New Zealand and the Government of Japan - Agreements on work holiday programs. The Youth Exchange Program (work on holiday) is open to nationals of the Contracting States and may be subject to multiple national visas for a maximum period of 12 months under these agreements.</p>

□ **According to the agreement between the Government of the Republic of Lithuania and the Government of Canada** on youth exchanges, Canadian citizens who are:

- young citizens, including graduates of university and non-university higher education institutions or research institutions, wishing to improve their qualifications in the host country under a pre-agreed employment contract in order to gain greater career prospects and show that they have a pre-agreed employment contract;

- registered students of university and non-university higher education institutions or research institutions in their country wishing to take part in their academic study program as a pre-agreed placement or work placement in the host country, including under contracts concluded between educational institutions and providing documents proving prior registration or registration at a university, non-university higher education institution or research establishment or demonstrating that an internship or work experience is taking place;

- Young citizens, including registered students who intend to travel in the host country, where their presence is related to tourism and cultural cognitive activities and occasionally work to supplement their financial resources and confirm their intentions.

The Youth Exchanges program can be attended up to two times and only if citizens meet the requirements of the two different categories listed. The periods of stay must be interrupted. The duration of each stay may not exceed one year.

Citizens of Canada intending to enter the Republic of Lithuania under the Youth Exchange Program at the time of application for a national visa must be 18 - 35 years old. age; have a valid passport and return ticket or have sufficient financial resources to buy it; to go to the Republic of Lithuania alone (without dependents); prove that you have sufficient financial resources to meet your needs at the start of your stay; pay all established fees; have health insurance for the entire period of stay in Lithuania.

Temporary residence permits and work permits during their legal stay may be issued to Canadian citizens who have the right to benefit from the Youth Exchange Program and who hold a multiple national visa issued on that basis upon their arrival in the Republic of Lithuania.

□ **According to the agreement between the Government of the Republic of Lithuania and the Government of New Zealand** on working on a holiday program, citizens of New Zealand who wish to vacation may enter the Republic of Lithuania while having the opportunity to study and gain work experience:

- the date of application is 18 to 30 years old;

- have a valid travel document issued for the last 10 years, which is at least 3 months longer than the period of validity of the visa requested;

- points out that the main purpose of a trip to the Republic of Lithuania is to take part in a holiday program, i.e. leave, and work or study is not the main reason for the visit;

- not with dependents;

- submit a document confirming that they have sufficient funds and / or receive regular income in the Republic of Lithuania and funds to return to the country of origin or foreign state to which they have the right to travel;

- have a health insurance document;

- has paid a fee set by the legislation of the Republic of Lithuania for a multiple-entry national visa application;

- previously did not participate in this work holiday program.

New Zealand citizens arriving in the Republic of Lithuania on a work holiday program are not subject to the requirement to obtain a work permit in the laws and other legal acts of the Republic of Lithuania. It should be noted that New Zealand citizens who have arrived in the Republic of Lithuania during their work holiday program are not allowed to be employed for a permanent job or work for the same employer for more than 6 months during the period of stay in the territory of the Republic of Lithuania.

□ **According to the agreement** between the Government of the Republic of Lithuania and the Government of Japan on work on a holiday program, citizens of Japan residing in Japan will be able to enter the Republic of Lithuania:

- points out that the main purpose of a trip to the Republic of Lithuania is holiday;

- the date of application is 18 to 30 years old;

- not with dependents, except those who hold a multiple national visa or another visa issued by the Republic of Lithuania under the said agreement;

- have a valid travel document issued during the last 10 years, which is at least 3 months longer than the period of validity of the visa requested;

- have a return ticket or sufficient funds to purchase such a ticket;

- submit a document confirming that they have sufficient funds and / or receive regular income in the Republic of Lithuania during the period of validity of the multiple national visa;

- indicates that it intends to leave the Republic of Lithuania after the expiry of the multiple national visa;
- did not previously participate in work holiday program;
- has a health insurance document.

Japanese citizens who have arrived in the Republic of Lithuania under a holiday work program are not subject to the requirement to obtain a work permit laid down in the laws and other legal acts of the Republic of Lithuania, they may be employed and enrolled in training courses or study for a period of up to 6 months in the territory of the Republic of Lithuania, but are not allowed to be employed on a permanent basis work or work for the same employer for more than 6 months during the period of stay in the Republic of Lithuania.

#### **NOTES:**

Application for the issue of a national visa and accompanying documents shall be submitted to the Lithuanian visa authority in a foreign country or through an external service provider. If the state, where the applicant is legally resident, there is no Lithuanian visa service or external service provider, the application and documents may be submitted to any Lithuanian visa authority abroad or through any external service provider application center. If foreigner is not a national of the State in which documents are submitted for the purpose of obtaining a national visa, he must produce the documents, his legal position in that country. Applicants for a national visa examination reveal that foreigner in the State where the request is illegal, the examination is terminated.

An application for the issue of a national visa and the accompanying documents may be submitted to the visa authority in Lithuania if foreigner is legally in the territory of the Republic of Lithuania.

Foreigner fingerprints are taken. If fingerprints of a foreign national applying for a national visa were taken less than 59 months before the date of submission of the new national visa application, they are copied to a subsequent request. In this case, documents may be submitted by an authorized person on behalf of foreigner for the purpose of obtaining a national visa. He must submit a power of attorney approved by a notary or equivalent, or a power of attorney approved by a legal person. An authorized person on behalf of foreigner serving documents to a visa office in Lithuania must be legally resident in the territory of the Republic of Lithuania. If there is a suspicion of foreigner's destination, the authenticity of the documents submitted, the visa official may, in order to ascertain the credibility of foreigner, require foreigner to present the documents personally and, in the event of reasonable doubt as to the identity of foreigner, to take fingerprints without the specified period.

The application and examination of a national visa application accompanied by the attached documents shall be governed *mutatis mutandis* by the provisions of Article 6 of the Visa Code (Regulation (EC) No 810/2009 of the European Parliament and of the Council 2009-07-13) as well as Chapters II and III. If the application for a national visa is submitted in a manner other than that provided for in the Visa Code, the request shall not be considered and the applicant shall be informed thereof.

If the visa office provided only copies of documents - their authenticity must be attested copies certainty testimony of an authorized person or institution.

No Lithuanian language documents drafted Lithuania visa service accompanied by a translator's signature certified translation into the Lithuanian language.

Visa service civil servant, in justified cases (for example, in order to clarify the circumstances of foreigner's entry into the Schengen area; in case of reasonable doubt as to the authenticity of the submitted documents or their content; in order to determine whether there are grounds for refusal of a national visa referred to in Article 19 of foreigners Law) may invite an applicant for a national visa for an interview and / or request additional documents confirming the data contained in the national visa application and the accompanying documents.

The decision to issue a national visa is made within 15 calendar days from the date of the request. This period may be extended by up to 45 calendar days.
